



## **IUCN-ELC Internship Programme**

- Are you a highly motivated individual looking for an internship?
- Are you studying environmental law or have strong legal components in your studies?
- Are you in a post-secondary education institution or completed your law studies?
- Are you looking to gain experience in multicultural and international surroundings?

The internationally-renowned IUCN-Environmental Law Centre accepts interns on a regular basis for periods of 3 months or more. The Centre is located in the international city of Bonn, Germany and is an integral part of IUCN, whose headquarters are in Gland, Switzerland.

Together with IUCN Commission on Environmental Law, the ELC has a highly respected profile internationally, based on over 30 years of proven commitment to environmental law. The "Observer" status which has been awarded to the IUCN by the United Nations, allows the ELC to collaborate closely with the numerous UN agencies (see IUCN ELP Website: [www.iucn.org/themes/law](http://www.iucn.org/themes/law) 'Information and Publications' 'Relevant Links') active in the environmental field. It has well-developed links with those intergovernmental organizations and non-governmental organizations who have also made Bonn their headquarters.

An internship with IUCN-ELC is meant to further the individual's practical experience in the field of environmental law, through assisting the ELC professional staff in the preparation of reports & projects (including research), conferences & workshops on the agenda of the Centre during the internship period. The ELC has an international staff and the intern will be working in a multicultural environment. The office language is English, however, other languages are clearly useful, in particular French and Spanish (also official languages of the IUCN) and German. Throughout the internship, he/she will be able to have access to the extensive collection in the ELC Libraries, considered amongst the best in the world, in the field of environmental law.

Bonn is an international city, centrally-located and bordering the Rhine River. Cologne and Frankfurt are close by and other major European cities such as Amsterdam, Brussels, Berlin and Paris are easily reached by train.

IUCN-ELC is a non-profit organisation and is thus not in a position to offer its interns remuneration. All interns therefore need to be self-funding. The ELC provides the interns with their own working space, including computer/internet access. At the start of an internship, the intern is assigned to an ELC professional staff member. The tasks assigned to the intern are intentionally varied, not only to allow the intern to gain experience at working within an international organization but also to maximise his/her contribution to the work and objectives of IUCN.

### **General Conditions**

IUCN-ELC internships are appropriate for highly-motivated young students and young lawyers from around the world who have a background in environmental law or studies with a significant legal component. With a view to contributing to their vocational training, IUCN-ELC places great importance on internships as a significant tool in supplementing the interns' knowledge and education with real hands-on experience, enabling them to understand the way in which an international organization functions and to broaden their knowledge and awareness in the field of environmental law

### **Interns must**

- be between **18 & 30** years of age;
- be enrolled in or completed studies at university, or higher level institution, either in environmental law or in a course of studies with a strong legal component;
- have a thorough knowledge of English (written & spoken) and preferably a good knowledge of a second language, especially French or Spanish. German is also useful.
- be computer-literate, preferably with experience in data-bases and internet searches.
